

**GENERAL POWER OF ATTORNEY  
AND AUTHORIZATION FOR RELEASE OF PERSONAL INFORMATION**

BONDS(S) and all rewrites \_\_\_\_\_

TO ALL PERSONS: be it known that I, \_\_\_\_\_, Grantor do hereby make and grant a general and irrevocable power of attorney to **Thomas Free**, dba **Free Bail Bonds** or their assigns, and do thereupon constitute and appoint said individual as my attorney-in-fact.

My attorney-in-fact shall have full powers and authority to do and undertake all acts on my behalf that I could do personally, with full power of substitution, including but not limited to by said authority the right to seize, sell, deed, buy, trade, lease, mortgage, assign, rent or dispose of any of my present or future real or personal property, including but not limited to motor vehicles, motor homes, boats, airplanes, trailers, sea-doo's, jet skies, atvs, etc.; the right to execute, accept, undertake and perform any and all contracts under my name; the right to retain any accountant, attorney or other advisor deemed necessary to retire debts as a result of this bail contract, such debts include, but not limited to unpaid premiums, full amount of said bond(s) if forfeited by the court, any and all expenses, any investigation fees as a result of violating any of the conditions set forth by this bond contract; such fees billed at a rate of no less than \$200.00 per hour with a 2 hour minimum; the right to access and seize all accounts, including but not limited to, bank, savings, checking, retirement, certificates of deposit, safe deposit box(es), life insurance policies, stocks, bonds, mutual funds, tax refunds, payroll checks, unemployment checks, disability checks, royalty checks, etc. until all debts are retired. Any cash and/or jewelry that I may have on my person at time of arrest, or otherwise as a result of said breach of contract may be seized from my person and applied to retire said debts. I further authorize my attorney-in-fact, or his assigns, to enter my dwelling, whether or not I am listed on the lease or mortgage, in order to seize any of my property, real or personal to be applied to retire any debts. With respect to any obligation between myself or any other obligor and the agency, it is my clear and expressed intention that any debts incurred as a result of a breach of contract be retired by way of this power of attorney in fact has full authority to retire any outstanding debts, as he/she deems necessary.

For the purpose of securing any and all amounts which may come due under this obligation. I understand that this agreement authorizes **Thomas Free**, dba **Free Bail Bonds**, or his assigns, to place his/its name on my vehicle(s) title(s) as lien holder for the purpose of perfecting this security interest. I further agree that in the event I acquire another vehicle prior to satisfying my obligation, it too shall secure my duties under this obligation. I understand that the power of attorney will authorize **Thomas Free**, dba **Free Bail Bonds**, or his assigns, to take any steps necessary to perfect its security interest, i.e., duplicate title and/or lien holder status on any new or other vehicle(s).

I do hereby authorize, voluntarily and without coercion, the review and full disclosure, and be provided a copy of any and all records concerning myself under this name or later discovered by **Thomas Free**, dba **Free Bail Bonds**, or his investigators, whether the records are of a public, private or confidential nature, including, but not limited to, the right to receive records, telephone, utilities, credit, medical, dental, social security, criminal, civil, police, school (both for myself and children) motor vehicle, medical, employment, pre-employment, unemployment, NCIC records, Internal Revenue Service, United States Postal Service, and the recollections and/or records of attorney at law, or other counsel representing me or another in any case, civil or criminal in which I have or have had an interest or party thereof.

This power of attorney shall not be affected by disability of the Grantor. Until **Thomas Free**, dba **Free Bail Bonds** or its agents, have been provided with an original and verified certificate of discharge and/or exoneration by the Court of Jurisdiction on the surety bond(s) listed, and ALL financial obligations by the Grantor have been met, this power of attorney shall REMAIN IN FULL FORCE.
